SS-38 is a 1-part silicone adhesive that when applied to the substrate, cures to a pliable, removable protective covering within a day. When cured, the elastomer resists weathering, ozone, moisture, UV and high temperatures. SS-38 works well in automatic and manual dispensing equipment.
