

Curing

Cure speed can be accelerated with increased humidity and heat to very rapid cure times. Typical utilization involves dispensing in open air and after exposure to ambient humidity, a room temperature cured rubber is formed.

Oxime

Limitations

Do not use product on head gaskets, solvent or fuel immersion applications. Allow to fully cure before putting assembly into service. Ensure enough product remains between flanges to be effective in an assembly.

For maximum shelf life, keep containers sealed when not in use. Keep out of the reach of children. Uncured sealant irritates eyes and skin. Refer to the SDS.
